Terms and Conditions of Membership as per the Constitution of the Mangere Cosmopolitan Club Inc

1. Membership of the Club shall consist of Ordinary and Life Members as hereinafter defined:
 - (a) Ordinary members shall be males or females of the full age of eighteen (18) years or such lower age as may be authorised by the Sale of Liquor Amendment Act (No 2) 1989 and its amendments or any Acts or Act passed in substitution thereof and shall be entitled to the following:
 - (1) Entry to the Club's premises during such hours as may be defined by the Committee.
 - (2) The right to vote at meetings of members and hold office in accordance with the rules of the Club.
 - (3) An equal voice in all business of the Club.
 - (b) Life members shall be:
 - (1) Ordinary members who have completed thirty (30) years membership provided the total number does not exceed 5% maximum of the total membership at any time and shall be entitled to all rights and privileges of Ordinary Members.
 - (2) Ordinary Members nominated by Notice of Motion for Life Membership as a reward for special services rendered to the Club shall have their Notice of Motion in the hands of the Secretary 28 (twenty eight) days prior to the date of the Annual General Meeting.
 - (c) Employees of the Club may be members of the Club and able to use the facilities of the Club but use of the facilities and entitlement to claim any prize related to their membership shall be suspended during any hours that they are so employed.
 - (1) They may be permitted to join any sub-section of the Club at any competition, should they be selected, provided it not be a day or night they are on duty.
 - (2) They may not be eligible for any Executive position.
2. Each candidate for membership shall be nominated in writing on a form provided for the purpose by two financial members of the club. The nomination form shall include the Christian names, Surname, day and month of birth (year optional) and residential address of the candidate and an undertaking that he/she will abide by all rules of the Club. The candidate shall deposit at the time of nomination, such sum as may be directed by the Committee. The names of candidates shall be posted on the Club's notice board for fourteen (14) clear days prior to election.
 - (a) Any objection in writing signed by the objector and lodged during the period of posting shall be considered by the Membership Committee.
 - (b) Members nominating and seconding candidates for membership must have been a full member for at least one year (12 months).
3. Membership may be terminated:
 - (a) By resignation: Any member may resign his/her membership by a letter addressed to the Secretary of the Club to that effect stating the reasons for the resignation and by paying all subscriptions owing at the date of such letter of resignation.
 - (b) By expulsion: Any member who misconducts themselves or commits an offence under all Rules renders themselves liable to a fine, suspension, or expulsion by a unanimous decision of the Disciplinary Committee. A member charged with an offence shall be summoned by registered mail or personal serving of a notice to appear and be heard by any meeting called to consider the complaint. Inability to attend must be notified to the Secretary Manager or the Assistant Secretary by the Friday prior to the meeting. Should a member not attend a second meeting called the complaint shall be heard in his/her absence.
4. No expelled or retiring or forfeiting member shall have any claim upon the Committee or the Club either collectively or individually to any property of the Club.
5. Subscriptions:
 - (a) For Ordinary Members the sum of \$55.00 or such sum as shall be fixed from time to time by the Members at the Annual General meeting of the Club or any Special General Meeting called for that purpose.
 - (b) Life and Associate Members shall not be liable for the payment of any subscription.
 - (c) Permanent beneficiaries or Superannuants who have been a member of this Club for not less than (3) three years pay \$28.00 subscription. To qualify for the Senior Member or Cat 'B' Subscription Rate a member must be:
 - (1) Be 60 years of age; OR
 - (2) Be in receipt of Permanent Disability Full-Income Sickness Benefit, with the proviso that a doctors certificate may be required at the discretion of the Management Committee.
 - (d) A nomination fee as set from time to time by the Committee be charged on initial application for membership, and any subsequent re-application if the applicant has allowed his or her membership to lapse for a period greater than one (1) year.
 - (e) Transfer of membership may take place only on the death of a member, and such transfer is eligible only to the deceased member's immediate spouse on application to the Membership Committee.
6. Every subscribing member shall not less than 28 days before their subscription becomes due be notified in writing to that effect. Those members who remain unfinancial at the 30th September shall be considered as unfinancial and informed that their name will be erased from the membership list on 30th November without further notice unless reason can be shown that their membership should be reinstated in accordance with Rule 9 (b).
7. Those unfinancial members whose subscriptions remain unpaid at 30th September shall have their names erased from the roll of Members and shall be deemed to have retired from Membership. No appeal for reinstatement will be received after 30th November.
8. Provided that any Member upon leaving his/her last known address for any period exceeding three (3) months or being incapacitated by illness or accident may on proof of the same being given to the satisfaction of the Convener of Membership be reinstated from such date as may be decided.
9. For all purposes in connection with the holding of a General Meeting or an election or the nomination of a Candidate for Office or for Membership the subscribing member shall not be deemed to be financial unless his/her subscription is paid up to the end of the current subscription year and they have no other outstanding financial debt to the Club.
